AGENDA ITEM 8, OLD BUSINESS

A. Progress report on Public Works projects, Successor Agency Oversight Board, South of Tioga project, Coastal projects, and other Sand City community programs by City Engineer/Community Development Director/City Administrator.

City Engineer Leon Gomez reported that the desalination plant has produced 11 AF since last Friday. Cal-Am is currently reviewing bids for rehabilitation of Tioga well #5. They anticipate rehabilitation efforts to start within the next 30-60 days with the work taking approximately 3 to 5 weeks to complete. The rehabilitation work would increase well productivity and conductivity that directly influences the discharge capacity of the plant. Staff is presently working on a review of the Storm Water Management Program's online system, and the resolution of an issue involving a curb return of a fire hydrant at the corner of Hickory that was replaced by Cal-Am. The replacement of the damaged fire hydrant does not meet ADA standards and may need to be relocated. Mr. Gomez reported on the process of what should have occurred in this situation, such as Cal-Am obtaining and completing an encroachment permit prior to the fire hydrant being installed.

There was Council discussion regarding the continued production of the desalination plant while the wells are undergoing rehabilitation.

Interim City Administrator Kelly Morgan, reported on the Coastal Commission hearing on the findings of the SNG, Monterey Bay Shores Resort project. The Commission approved the revised findings. Mr. Ghandour was pleased with the Coastal Commission's ruling, and is preparing for future development and construction. Staff is working to organize a meeting with TAMC and the developer to review the road design going into the project. TAMC would like to see how the project will incorporate the bicycle trail and surrounding roads.

Mayor Pendergrass commented that LaTonya Olivier will facilitate the workshop, and he encouraged Council and Staff to review the requirements for the position of City Administrator.
