AGENDA ITEM 7, OLD BUSINESS

A. Progress report on Public Works projects, Successor Agency Oversight Board, South of Tioga project, Coastal projects, and other Sand City community programs by City Engineer/Community Development Director/City Administrator

City Engineer Leon Gomez reported that Staff is working on final updates to the Storm Water Management Program report that was submitted two weeks ago. The final report will be submitted to the Regional Board in early November. A regional training opportunity for municipal staff is being assessed and coordinated with the cities of Monterey and Pacific Grove. The training will consist of construction site inspections and what to look for in municipal operations. The desalination plant was inoperable for most of September. As the reverse osmosis membranes have reached the end of their useful life and are in need of replacement, new membranes have been purchased by Cal-Am and are awaiting approval by the State.

Mayor Pendergrass added that Cal-Am has been diligent in the maintenance and operation of the desalination plant. He encouraged Staff to expeditiously keep in contact with the Department of Health to receive quick approval of the new membranes for the plant.

City Administrator Steve Matarazzo reported that a mixed use development is being proposed at Ortiz and Catalina Avenues next to the Hawthorne building. The Peninsula Fence Company property is for sale and may presently be in escrow. Staff met with Mr. Silva of Woodman Development Company last Tuesday. They submitted a proposal to construct 10 single family dwellings on small lots. These are both indications of an improving real estate market.
