#### AGENDA ITEM 7, PRESENTATION

A. Mayor Pendergrass acknowledged Officer Jeff Bushnell as the 2008 Sand City Police Officer of the Year and Nancy Fletcher as the 2008 Support Services Person of the Year. Sand City is privileged to have supportive and hardworking employees on the Police Department staff who exemplify dedication above and beyond the call of duty.

Police Chief Klein thanked the Council for their support, as indicative of their presence at the awards ceremony honoring Officer Bushnell and Ms. Fletcher.

Vice Mayor Carbone presented a bouquet of flowers to Nancy Fletcher for her supportive role within the Police Department.

B. Associate Planner Katie Axt, from the Association of Monterey Bay Area Governments (AMBAG) presented the Monterey Bay Regional Blueprint Program. This program evaluates current trends related to population increases and demographic shifts within the area to develop a preferred land use scenario. The Blueprint Program also provides a forum for ongoing discussions and coordination between local jurisdictions related to issues of regional significance. The benefits of the Blueprint Program is that it establishes a foundation for working relationships and the necessary framework to implement State Senate Bill (SB) 375. It also allows grant competitiveness, and introduces a shift from housing element cycles from 5-year updates to 8-year updates. The first year's accomplishments of the Blueprint Program is the regional participation in the Forecast Technical Advisory Committee (FTAC) which resulted in the preparation of a 2008 Forecast of Population, Housing and Employment projections for the Monterey, San Benito and Santa Cruz counties. The primary goals for the program are to broaden agency education, further the development of the Visualization Platform, increase Public Outreach workshops, and to strengthen staff collaboration with local agencies in the Blueprint scenario development.

City Administrator Steve Matarazzo added that Sand City will have no problem meeting the land use Blueprint goals, and the AMBAG Planner agreed.

C. The presentation by Elizabeth O'Malley and David Wilkinson of Fine Art Base, a nonprofit organization for emerging artist, was moved to a future Council meeting at their request.

#### **AGENDA ITEM 8, PUBLIC HEARING**

A. Steve Prestwood, from Pacific Municipal Consultants (PMC), presented a report on the update to Sand City's Housing Element, emphasizing upon California State requirements and the inclusion of new goals and policies to meet those requirements. State law requires housing elements be updated every five years, and be reviewed and approved by the California Department of Housing and Community Development (HCD). The housing element is one of seven required elements of a City's General Plan, and is to reflect a communities housing needs and challenges, and outlining the policies to achieve housing goals. Having a State Approved Housing Element provides access to State grant funds. The overall purpose of the Housing Element is to present a comprehensive set of goals to meet housing needs, establish policies related to housing, and quantified objectives for implementing those policies. This Housing Element update will include a housing needs assessment based upon established Regional Element Needs Allocation (RHNA) for Sand City.

Mayor Pendergrass commented that Sand City is presently participating in homeless services and the Salvation Army's drop-in center located within Sand City should assist in meeting this requirement of the Housing Element. Sand City also pays a pro-rata share for various community services within the community.

Vice Mayor Carbone gave Mr. Prestwood additional information regarding Sand City's participation in the Community Human Services (CHS) Program.

City Administrator Steve Matarazzo commented that the Monterey Peninsula's largest constraint towards providing adequate housing is a lack of a water supply. Sand City's biggest accomplishment during the housing element period was creating a water supply which will be mentioned in the housing element report. This will satisfy the requirement that Sand City provide 120 housing units over the next 5 years, should the economy improve. Another factor which helps the affordability issue that the Housing and Community Development (HCD) may or may not appreciate is the real estate market which is doing poorly, dropping housing prices 30-40%. Water, mortgage rates, and the real estate price slump, which will improve, are all positive factors for future housing growth.

Mayor Pendergrass added that these are very unique and precarious times, and one great element is the water supply project which Sand City has accomplished.

Mr. Prestwood continued his presentation stating that Sand City's 2007-2014 Regional Housing Needs Assessment (RHNA) allocation is 120 new housing

units distributed across 5 standard income categories from extremely low, to above moderate income levels. There was a 30.9 % increase of Sand City's median household income within the last 8 years, and a I7.3% increase within Monterey County's median household income. The quantified objective is the production of housing units expected during the RHNA period, which includes the number of units expected through housing development and through City programs from 2009-2014. In conclusion, the Public Review Draft of the Housing Element Update should be ready some time in May, and finalized in June of 2009.

Council member Blackwelder asked how Sand City performed during the last five years and did Sand City meet all of the criteria as required in the housing element?

Mr. Prestwood commented that the final numbers will be included in the Housing Element Update.

Mr. Matarazzo added that there is still one program which needs to be implemented. Sand City accomplished having enough land zoned at appropriate housing densities and eliminated water constraints. The previous production numbers were not met due to the lack of water availability. When the economy improves, Sand City should be in the position to meet the requirements for the Housing Element.

## AGENDA ITEM 9, OLD BUSINESS

A. City Engineer Richard Simonitch reported that the tentative date for well testing is scheduled for the week of May 6, 2009. P.G. & E is expected to have power available to Tioga Avenue and Bay Street by then. The current progress at the desalination plant involves uploading software, enabling the contractors to test the block wells and complete the water test conditions for salinity. P.G & E. has begun their design for relocation of the poles on Elder Avenue. Public Works has filed a reimbursement claim to P.G. & E. for trenching work to be done for the power pole on Shasta Avenue.

Public Works staff prepared a presentation for the Local Engineers Club at the Seaside Council Chambers, and led a tour of the desalination plant immediately following that presentation.

City Administrator Steve Matarazzo reported that Sand City has been awarded the P.G. & E. grant funding for the desalination plant, however the plant needs to be fully operational before those funds are released.

A Coastal Commission hearing is scheduled for May 7 in San Francisco regarding the Monterey Bay Shores project. Staff is requesting that the Council keep that date open.

Mayor Pendergrass commented that the construction of the desalination plant is a large accomplishment for a small City. Staff has invited the Governor of California to attend the grand opening celebration probably to be held in August 2009.

#### 8:02 P.M. Floor opened for Public Comment

Mr. Steve Wilson approached the Council requesting how much of the desalinated water the City will actually receive before it is pumped into the mains?

City Engineer Richard Simonitch responded that water from the treatment plant must be blended with Cal-Am's water to meet quality standards for public use. He added that water use west of Fremont Boulevard will be using this blend due to water pressure within the Cal-Am system.

Mr. Wilson thanked the City Council and Staff for the excellent job they have done in bringing the desalination plant to Sand City.

#### AGENDA ITEM 10, NEW BUSINESS

- A. The Deputy City Clerk brought to the Council's attention the upcoming meetings and events. There were no RSVP's. Mayor Pendergrass announced Sand City's 49th Annual Barbeque is to be held on May 30, 2009.
- B. City Administrator Steve Matarazzo included the attached article "A Voyage into the Strange World of California Municipal Finance", by

Michael Coleman, for information only.

C. Associate Planner Charles Pooler presented conceptual renderings for a monument sign design at the Sand City Desalination Treatment Facility. Included are two material and color concepts, each design incorporating the building's materials and colors allowing for design consistency. The two options presented are 1) blue corrugated metal backing and 2) offwhite plaster backing. Staff recommends Council review and consensus on the design so that construction can be expedited.

The Council discussed and reviewed the options available with the choice to remain consistent with the City's overall esthetic appeal. There was Council consensus in favor of the corrugated metal backing design.
