AGENDA ITEM 6, CONSIDERATION OF ITEMS PULLED FROM CONSENT CALENDAR

There were no items pulled.

AGENDA ITEM 7, OLD BUSINESS

A. City Engineer Richard Simonitch reported that MGE is installing the underground lines, and vaults related to the desalination discharge well. The construction of the desalination plant building is on schedule, and moving forward. Staff has submitted the Coastal Access plans to the Coastal Commission for their review of the design concept. The Prop 40 Grant Funds progress report for the Beach Coastal Access has also been submitted.

Council Member Morris commented that his primary concern on the feed wells was that their location would require them to be moved after a few years due to coastal erosion.

Mr. Simonitch replied that Staff is looking into every possible alternative so that the wells will remain intact far into the future.

City Administrator Steve Matarazzo reported that Pacific, Gas and Electric would like to issue Sand City's Energy Rebate check before year's end. Staff will be attending a meeting on Friday at San Luis Obispo for the desalination discharge permit.

AGENDA ITEM 8, NEW BUSINESS

A. City Administrator Steve Matarazzo presented the consideration of a City resolution amending the Sand City Personnel Manual, Chapter 5, Section 5.14 Regarding the travel and expense policy for employees. At the request of the auditors, a formal policy needs to be adopted by the Council with regard to employee travel reimbursements. The attached staff report and resolution conforms with current IRS requirements with regard to employees who receive reimbursement to attend business related events. Staff recommends the approval of the attached resolution.

Motion to approve the City **Resolution** amending the Sand City Personnel Manual, Chapter 5, Section 5.14 Travel and Expense Policy for Employees was made by Council Member Blackwelder, seconded by Council Member Morris. B. City Attorney Jim Heisinger commented on the City resolution adopting a Council reimbursement policy. Sand City's Personnel Manual did not have a specific policy that would apply directly to City Council travel related expenses. The attached Council reimbursement policy would conform to current government code regulations. The changes to the existing policy are contained in the attached resolution and Exhibit A. It is recommended that the Council approve the resolution adopting a Council reimbursement policy.

Motion to approve the City **Resolution** adopting a Council reimbursement policy was made by Council Member Carbone, seconded by Council Member Blackwelder. AYES: Council Members Blackwelder, Carbone, Hubler, Morris, Pendergrass. NOES: None. ABSENT: None. ABTAIN: None. Motion Carried.

C. City Administrator Steve Matarazzo presented for the Council's consideration the approval of the wording for interpretive signs to be located at the end of Bay Avenue and Vista Del Mar. The sign area will be approximately 2' x 2', with additional information regarding what Sand City is all about. Staff recommends that the City Council approve the interpretive signs, which will be connected with the beach access improvements at the end of Bay Avenue. Once approved, Staff can then forward the information to the Coastal Commission for their final approval. The language for the two signs is specified in the attached staff report on page 73.

There was Council consensus to move forward with the wording for the interpretive signs.

D. Chief of Police Michael Klein presented a City resolution authorizing the Sand City Police Department to enter into a Grant Agreement and to participate in the "Avoid the Eighteen Driving Under the Influence (DUI) Campaign" with the Monterey County Law Enforcement Agency. The resolution would allow Sand City to participate as part of 18 law enforcement agencies in Monterey County which would provide DUI checkpoints, warrant teams, and saturation patrols along with various types of logistical and supervisory rolls. The dates and staffing needs for DUI checkpoints will be forwarded to all agencies when finalized. There are no current checkpoints presently located in Sand City. Staff recommends approval of the attached resolution authorizing the Sand City Police Department to participate in the "Avoid the Eighteen" DUI Program.

Motion to approve City **Resolution,** authorizing the Sand City Police Department to enter into a Grant Agreement and to participate in the "Avoid the Eighteen Driving Under the Influence (DUI) Campaign" with the Monterey County Law Enforcement Agency was made by Council Member Blackwelder, seconded by Council Member Hubler. E. Mayor Pendergrass commented on the City resolution in appreciation of Council Member Morris for his years of service and commitment to the City of Sand City. Mr. Morris has served several terms as Council Member since 1978 and the Mayor thanked him for his dedication as a public servant to the community. The Council would like to present a plaque and resolution to Mr. Morris at the City's Annual Awards Banquet.

Mr. Morris responded that it has been a pleasure to work with the members of the Sand City Council and thanked each Council Member individually for the good job they have done to keep Sand City moving forward towards a collective vision. Council Member Morris jestfully concluded that this will not be the last time he will be attending a Council meeting as he plans to be part of the audience especially when a future meeting covers projects near his residence.

Vice Mayor Carbone commented that it has been a pleasure to work with Council Member Morris and, if needed, he is just over the hill.

In conclusion, Mayor Pendergrass mentioned that Council Member Morris always came well prepared for the Council Meetings. He has been a true servant as one who works for the people to serve their City, and wished him much success in his future endeavors.
