7. PUBLIC HEARINGS

7:06 p.m. {Council members Blackwelder and Hubler stepped down from the dais due to the 500' rule}

A. Community Development Director, Steve Matarazzo presented City RESOLUTION Approving Conditional Use Permit 472 for a Restaurant and Coffee House at 1725 Contra Costa Street (Note: This item was continued from the March 28, 2006 Special Council Meeting). The primary concern was in regard to item number 6 of the conditional use permit, which required 10 additional parking spaces within 300 feet of the proposed use, a parking lease agreement was provided for Council's review. A special finding was added to the conditional use permit in reference to the parking lease, giving the business a better opportunity to grow in the interim. Staff believes that parking is essential to the surrounding areas in the West End. On street parking is not limited to the café only, but also serves the surrounding businesses.

Council Member Morris asked if the lessor were to cancel the lease agreement for the additional parking space, would that void the lease agreement?

City Attorney, Jim Heisinger answered that if the lessor cancelled the lease agreement and the applicant was unable to secure like number of spaces somewhere else, then the applicant would be in violation of the conditions of the use permit.

7:15 p.m. Floor opened to Public Comment

Morgan Christopher, applicant had no comment, requesting additional time to respond to any further issues the Council may have.

7:17 p.m. Floor closed to Public Comment

Further discussion involved adequate water for the proposed number of seats, and the classification of the business as a restaurant or café. Will the business continue to operate within the water district requirements, since Sand City does not have the capacity to provide additional water, should the business wish to expand its seating. Mr. Christopher added that there is no need to approach the Water District for additional water at this time, since his seating will be limited to thirty-six which is acceptable with appropriate turnover.

Motion to approve City RESOLUTION Approving Conditional Use Permit 472 as Amended Regarding Signing for Paving 4 Spaces in Front for a Restaurant and Coffee House at 1725 Contra Costa Street, with a special finding and by title was made by Council Member Morris, seconded by Council Member Carbone. AYES: Council Members Carbone, Morris, Pendergrass. NOES: None. ABSENT: None. ABSTAIN: Council Members Blackwelder and Hubler. Motion Carried.

B. Associate Planner, Charles Pooler presented City RESOLUTION Approving Coastal Development Permit 06-05 Allowing Randall Swanson to Operate an Art Wholesale Gallery at 1 John Street Unit B. The applicant intends to use the commercial unit for the marketing of fine art reproductions. There will be a showroom/gallery viewable to patrons by appointment only. There will also be an accessory office and storage area. Prints to be sold will be displayed, stored, and shipped. The applicant also proposes evening events with attendees by invitation only. Staff recommends limiting these events to no more than once per month with a closing time of 11:00 p.m. The daytime gallery use is not anticipated to generate impacts and on-site water credit is adequate to facilitate the proposed use. Staff recommends approval of the coastal development permit.

Randall Swanson, applicant, is in agreement with the conditions of the permit.

Council Member Morris voiced his concern regarding the parking during the evening events. Would the Council consider reviewing this permit should parking pose a problem?

Mayor Pendergrass, replied that most permits are reviewed once a year.

7:42 p.m. {Council member Carbone stepped down from the dais due to the 500' rule}

A. Associate Planner Pooler presented CUP #295, David Wilson (Open Storage), Park & Fell Streets (Note: This item was continued from the March 7, 2006 Regular Council Meeting). This permit was transferred to Mr. Wilson in 1988, from the original permittee. The fence presently contains wood slats, and the use of the property is in compliance with the use permit's conditions. The Council's consent would continue the use of the permit.

Council Member Morris, asked Mr. Wilson if he would be willing to slat the entrance gate and leave a couple of one foot windows so the police could look in the storage yard.

Mr. Wilson replied that he would be in agreement to what the Chief of Police would like. He is willing to do what needs to be done to remain in compliance with the permit and the council's request.

Police Chief, Michael Klein commented, it would be ideal to have a transparent view of the storage yard, making it easier to view inside as the officer's drive by. If it were to remain open, it should be visible enough so the officers on duty may view the yard from their vehicles.

Motion to accept CUP #295 and the existing land use and site conditions as being compliant with the permit, and directing the property owner to slat the gate, and allowing the continued use of the storage yard at the corner of Fell Street and Park Avenue was made by Council Member Morris, seconded by Council Member Blackwelder, AYES: Council Members Blackwelder, Hubler, Morris, Pendergrass. NOES: None. ABSTAIN: Council Member Carbone. Motion Carried.

7:54 P.M. **{Council Members Blackwelder and Hubler stepped down from the dais}**

A. Community Development Director, Steve Matarazzo presented City RESOLUTION Authorizing Building Permit Related Fee Reductions for "The Design Center" Mixed Use Development on Ortiz Avenue. Mr. Saroyan requested some permit fee relief for the proposed Design Center project. California provides for permit fee relief to projects that provide affordable housing opportunities. Staff is recommending a \$27, 720.80 fee reduction for this project, with a breakdown of these fee reductions explained in the staff report.

Mr. Al Saroyan, developer, commented on behalf of the development team, that whatever support the City can provide is very much appreciated. It is a small percentage of the total amount of fees that needs to be paid, and he realizes that these fees are not under the total control of Sand City. He is hopeful other agencies will also consider reducing permit fees to ease the burden of almost \$400,000 in cumulative fees. Construction on the foundation was planned to begin several weeks ago, but the weather has not cooperated. Once the steel arrives, it is estimated to take five weeks before the building is constructed.

- B. Stan Kulakow, City Engineer reported that interviews were held for the desalination project consultants. There were three consultants interviewed, and we are waiting fee proposals from two of these consultants. Once these fees proposals are submitted, the interview team will meet to review the proposals and submit these proposals for Council's approval. The desalination plant will be concentrated on the Campos Property as far as the design of the desal facility. Bids have been received for the stripping work for the new parking lot behind City Hall. It will not begin for several weeks due to the rain.
