#### **AGENDA ITEM 4, COMMUNICATIONS:**

- A. The additional written communications distributed to the City Council this evening included articles from the Monterey County Herald referencing Jerry Kehoe
- B. Mayor David Pendergrass welcomed Steve Beal who is standing in for Jim Heisinger, City Attorney.

The floor was opened to Public comment at 7:05 p.m.

There was no comment from the Public.

## **AGENDA ITEM 5, CONSENT CALENDAR:**

The Consent Agenda consists of routine items for which City Council approval can be taken with a single motion and vote. A Council member may request that any item be placed on the Regular Agenda for separate consideration.

- A. There was no discussion of the August 2, 2005 Meeting Minutes.
- B. There was no discussion of the Monthly Police Department Report, July 2005.
- C. There was no discussion of City RESOLUTION Authorizing Acceptance of an Allocation from the Supplemental Law Enforcement Services Fund (SLESF) and Appropriation of those Funds for Fiscal Year 2005-2006
- D. There was no discussion of City **RESOLUTION Authorizing a Contract for Services with Clearvue, Inc,**
- E. City Administrator, Kelly Morgan brought to the council's attention that the contributions have not been made yet and is subject to the council's approval. Approval of City Contributions/donation to North Fremont District of Monterey for Monterey on Ice at the Fairgrounds for \$500 and to Seaside Pony Baseball & Softball for \$100
- F. Council member Morris asked if Propertyroom.com will dispose of the shuttle bus and the process in which this entails. Chief Klein responded that this company has a good record of disposing of heavy equipment. They will arrange for pick-up and the bus will be stored at their facility. The City will receive 50% or up to \$1,000 dollars in proceeds from the sale of the shuttle bus. Approval of City RESOLUTION Authorizing Renewal for a Service Agreement with Property Bureau D.B.A. Propertyroom.com to Dispose of Surplus City and Evidence Room Property.

# **AGENDA ITEM 7, PRESENTATIONS:**

Barbara Griffman, made a presentation on behalf of "Friends of the Sea Otter" foundation making an appeal to the Council in support of HR2323 a Bill currently in congress to provide funds necessary to research and identify the causes of increased sea otter deaths and illnesses. The research could

also find a cure and/or prevention for other wildlife living in the Monterey Bay area.

Council member Morris questioned the efficiency of such legislation based on the fact that the lack of an adequate sea otter food appeared to be the main problem.

### **AGENDA ITEM 8, PUBLIC HEARINGS:**

A Discussion of FIRST READING:Ordinance of the City of Sand City Amending Certain Provisions of Title 10 of the Sand City Municipal Code Regarding Stopping, Standing and Parking. Chief Michael Klein explained that the old ordinance is no longer in conformity to the present needs of the City. The City Attorney and Sergeant Crisan have worked to update the old ordinance. Further discussion included the subject of apron parking, vehicle abatement and abandoned vehicles. Council member Morris questioned why other cities do not have this same issue. Chief Klein responded that other cities have parking enforcement officers which strictly enforce the issue of parking. Council member Morris suggested that related parking problems be continued for further discussion in the next agenda.

7:37 p.m. Floor opened to Public Comment

Resident Todd Kruper asked why this ordinance was not posted in and around the City. City Administrator, Kelly Morgan responded that the ordinance was advertised in the Herald as a Public Hearing Notice. It does not include the full explanation of the ordinance. Mayor Pendergrass commented that this is only the first reading of the ordinance.

Motion to approve First Reading of Ordinance of the City of Sand City Amending Certain Provisions of Title 10 of the Sand City Municipal Code Regarding Stopping Standing and Parking was made by Council member Morris. # **AGENDA ITEM 9, OLD BUSINESS:**

A. City Engineer, Stan Kulakow reported on the slurry sealing of city streets. A meeting is scheduled with the City of Monterey to meet with their engineers so we do not need to go through the entire bidding process. The City of Carmel has used this same process. Community Development Director, Steve Matarazzo, reported that on August 5<sup>th</sup>, he met with Jacob Martin of the US Fish and Wildlife to review the alignment of certain water lines involving the desal project, and the intake wells, with no apparent USFWS problems regarding the locations. A letter should be received within the next two weeks that no take permit would be necessary for the desal project. The subject of the Bike Trail Lights also did not appear to be an issue with the US Fish and Wildlife.

#### **AGENDA ITEM 10, NEW BUSINESS:**

- A. The regular council meeting scheduled for Tuesday September 6, 2005 has been cancelled. The next regular scheduled Council Meeting will be on Tuesday, September 20, 2005. City Administrator, Kelly Morgan pointed out the change of date on the last page of the agenda.
- B. Community Development Director, Steve Matarazzo, reported that there has been ongoing discussions with the chief permit official for the Coastal Commission; we will be submitting a coastal development permit, for the 15' lights we have. It was suggested that every other light from Bay Avenue south be turned off, so as not to obscure the ocean view.
- City Administrator, Kelly Morgan presented to the council, the need for the City to acquire the services of Orrick, Herrington and Sutcliffe, to begin financing analysis on the City Desal Project. The OHS firm is a top municipal finance law firm which deals primarily in obtaining financing options for large projects. If the council approves the services of the OHS firm, they will work in conjunction with Jim Dudick to prepare a summary analysis of the various financing arrangements. Council member Morris commented that the resolution should include an amount to item 1, that services should not exceed \$7,500 for the first phase of work. City Administrator, Kelly Morgan responded that whatever the amount of the financing obtained, the legal fees will be included in that cost.

Motion to approve City RESOLUTION Authorizing Engagement Letter for Legal Services with Orrick, Harrington & Sutcliffe by title as amended was made by Council member Carbone, seconded by Council member Hubler. AYES: All Council Members. NOES: None. ABSENT: None. ABSTAINED: None. Motion Carried.

D. The Deputy City Clerk received responses for upcoming events and meetings. The League of California Cities Conference registration and hotel accommodations have been confirmed.
