Consideration of Conditional Use Permit application for Nadar Agha to convert a portion of an existing 2nd floor warehouse area into self storage, located at 679 Redwood Avenue (APN 011-194-007 & 008). The project qualifies as a categorical exemption under State CEQA Guidelines, Section 15301, and is within a non-coastal Planned Mixed-Use zoning district.
- D. Consideration of Conditional Use Permit application by James and Venus Watari to establish a fast food style service within a portion of an existing building located at 679-A Redwood Avenue (APN 011-194-007 & 008). The business is intended as a food delivery and take out operation with limited on-site seating. The project qualifies as a categorical exemption under State CEQA Guidelines, Section 15301, and is within a non-coastal Planned Mixed-Use zoning district.
