AGENDA ITEM 7, PUBLIC HEARING

- A. Draft Ordinance adopting amendments to portions of Title 15 of the Sand City Municipal Code pertaining to Fire Code requirements for fire extinguishing sprinkler systems was presented by Associate Planner Pooler. These code updates are similar to those requirements adopted by the other communities in California. Our fire department, the City of Monterey, is recommending the adoption of these new regulations as being essential to providing adequate fire protection. Staff is recommending the adoption of the draft ordinance to incorporate the new requirements into Title 15 of the Code. The City Attorney made some clerical corrections to the draft ordinance.

- A. Associate Planner Pooler reviewed the Planning Department memo's in the packet and reported that the need for water is outweighing available resources. Staff is recommending that we do not go out for an RFP to prospective developers for the Dias Avenue properties at this time. After Council discussion, it was decided to bring this issue back to the Council after the first of new year.
- B. Progress Reports on Sand City projects and other Public Works Projects. City Engineer Kulakow reported the Bike Trail lighting would be ready to go out to bid the second meeting in November. City Administrator reported staff is working with Costco to add a gas station and to enlarge their building. One of the main issues to work out is the traffic impact. He is scheduling a meeting with the Interim City Manager of Seaside, Les White to go over several issues regarding Seaside and Sand City. The Granite Rock safety alarm has been disconnected. Granite Rock is researching other possible safety alarms.
