# **AGENDA ITEM 4, COMMUNICATIONS:**

- A. Additional written communications distributed to City Council this evening included two Herald news articles on the City of Seaside 1) potential legal action against the Water District and 2) a court judgement against the city by an employee (item 4-A); Water Management District staff report/ presentation regarding water credit transfers and on-site water credits (item9-B); March 5<sup>th</sup> Coastal Commission letter on the status of LCP and periodic reviews (item 9-B); and updated Sand City response to the civil grand jury (item 10-B).
- B. The floor was opened at 7:04 p.m. for oral communications from the public. JEANINE ROBINETTE (Tobacco Free Education): Presented the City Council with their 2001 annual report on tobacco education on the central coast. There has been a reduction in tobacco sales to youths, no-smoking in the workplace compliance, and an annual drop in sales to name a few improvements. There were no comments or questions by the City Council.

under the Federal Omnibus Crime Control and Safe Streets Act of 1968. The JPA is no longer necessary due to the method that these prevention programs are now funded by the state.

### **AGENDA ITEM 7, PRESENTATION:**

A. Mayor Pendergrass presented the City resolution to 2001 Police Officer of the Year Vito Graziano. Police Chief Klein summarized Corporal Graziano's valor and employment history with the City. Corporal Graziano thanked the Mayor, City Council, and staff; and introduced his family.

# AGENDA ITEM 8, PUBLIC HEARING(S):

[Due to residing within 500' of the project area, Councilmembers Blackwelder, Hubler and Kruper may have a conflict of interest. A straw-drawing was held, and as a result of that drawing Councilmembers Blackwelder and Huber were excused from participating in this agenda item. They left the dais and joined the audience.]

A. Associate Planner Pooler presented the Conditional Use Permit application by Joe Rosa to utilize a portion of an existing building at 495 Elder Avenue (APN 011-237-022) to facilitate a radio station studio with offices, and a real estate office. The project qualifies as a categorical exemption under state CEQA Guidelines, Section 15301, and the project is located within non-coastal Heavy Commercial (C2) zoning district. Equipment on-site will include electronic mixers, boards, and one satellite dish on the roof. The proposed radio station studio and real estate office uses are both consistent with the newly approved General Plan. A portion of the station's programming is received through the dish from sites throughout the nation. All programs are then transmitted via telephone line to either four broadcasting antennas in Salinas or one antenna in Monterey. No water allocation is required, and staff does not anticipate this type of use to generate noise, vibration, or pose a general nuisance to the surrounding area.

JOE ROSA (Applicant): In response to a question, their radio station will play oldies (50s, 60s, 70s) music. Councilmember Hubler asked if he will be

adding any soundproofing for outside noise (he pointed out that there are some fabrication shops in this area)? Carl Wilaford (Engineer) said they surveyed the area and they do not see any particular problem that they couldn't handle and they will not be creating noise to bother neighbors.

# **AGENDA ITEM 9, OLD BUSINESS:**

[Due to a possible conflict of interest by residing within 500' of the project area, Agency member Blackwelder was excused from participating in this agenda item as determined at a prior Council/Agency meeting.]

Report by Redevelopment Agency Attorney on the proposed process to A. dispose of 443 Orange Avenue property. Mr. Heisinger gave background information of the property acquisition. He and Mr. Morgan did a walkthrough and the house is very rundown. As owner, the Redevelopment Agency has full authority to sell the property. The Agency could impose conditions that would ensure the buyer will use the property for redevelopment purposes. The Redevelopment Agency does not have a separate land use plan and would defer to the new General Plan for consistency. Any City requirements upon sale can be accomplished by a deed restriction to the new owners. There are two procedural requirements, depending on how it will be developed or used: 1) four or fewer residential units, made available to low/moderate income tenants and "excess profiteering" is not allowed and could be part of the deed restriction. 2) a report must be generated by the Planning Department (as required by community redevelopment law) setting forth facts to calculate what funds are involved (to date the Agency has spent approximately \$112,000-\$114,000). An appraisal will also be necessary. Once the report is approved by the City Council the Redevelopment Agency is free to sell the property; and the Agency must decide if they want to control how the property is used in the future. Then staff will return with a list of options on how to dispose of the property. The Redevelopment Agency gave consensus to direct staff to prepare the required report and return the item at a future meeting, with some potential development options.

[Agency member Blackwelder returned to the dais.]

B. Progress report on Public Works projects, City water project, Project Study Report, pending coastal development projects and other Sand City community programs by City Engineer/Community Development Director/City Administrator. The Water District staff report and March 5th Coastal Commission letter were distributed this evening. City Engineer Kulakow reported that CalTrans is in the process of replacing deteriorated fencing along Highway One, and the next phase will be the east side of the freeway. He will be interested to see how they handle the shifting dunes. The 12" California Avenue water pipeline will be installed on March 18th at the Shurgard site and will tie into the Ortiz/Holly capital improvements completed a few years ago. Community Development Director Matarazzo reported on the letter he received from HCD that supports the City's housing element and which went on to offer assistance to find funds for the desal project. The City will also seek their political support in the future for the desal Coastal Development Permit from the Coastal Commission.

### **AGENDA ITEM 10, NEW BUSINESS:**

A. Agency Planner Matarazzo presented the staff report (not a resolution as previously listed) seeking minute action direction to apply for an Economic Development Administration (EDA) Planning Grant related to pre-development activities. This item was advertised as a public hearing. This grant is for environmental site assessments (hazardous waste determinations) and a market study for the Robinette site. The total grant request would be up to \$121,000 of which 70% is reimbursable from the federal EDA and the remaining 30% would be paid for by the Redevelopment Agency or property owners. Keyser Marsten estimates the market study to cost approximately \$25,000. City Administrator Morgan said that it is a good idea to do preproject grants with the EDA prior to implementation of a large project. They are then well aware of a project that seeks their further endorsement.

Redevelopment Agency gave consensus to proceed with the application.

B. City Administrator Morgan presented the City response to the 2001 Grand Jury report regarding beaches and urban runoff. There was an updated response distributed this evening that included the shopping centers percolation systems and servicing, and the street sweeping contract with the City of Monterey and HOPE Rehabilitation contract for general clean up. City Engineer Kulakow said that the response mentioned the City's participation

in the storm water task force. City Council gave consensus to send the response to the grand jury.
