### IV. NEW BUSINESS

- A. Mayor' Event on the day of the music event: The idea was brought to the table by Todd to have an early morning Mayors coffee for the local peninsula dignitaries. The Committee thought it was a viable idea and directed Todd to contact the Mayor for comment.
- B. Time of the event: Discussion of the event time was confused from the last meeting. Denise asked if there needed to be a letter for the group show that the Committee agreed that this could be done by word of mouth.
