## STATEMENT REGARDING DISCUSSION FOR MANDATORY VACCINATION POLICY

What makes Sand City so special is the City has never stepped away from controversial issues that affect everyone in our community. As council members and elected officials, you ALL have the responsibility to protect the citizens against unconstitutional and medical Covid-19 vaccine mandates.

In this discussion, NO Covid-19 vaccines are FDA approved but some are authorized under a temporary Emergency Authorization as experimental agents only.
