

1. General Description of Red Dress Day project and activities to be used by event planners and organizers as needed:

Supporting Indigenous Communities Group (SICG), with fiscal sponsorship provided by 501c3 Pajaro Valley Ohlone Indian Council, is seeking grant or individual donor support to support the planning, organizing and implementation of an Indigenous Education, Arts and Culture event Red Dress Day: Raising Awareness of Missing and Murdered Women, Girls and Two Spirits (MMIWGTS) that will take place at Oldemeyer Center in Seaside, California, and is scheduled for Saturday, May 6, 2023. This event is open to ALL Indigenous communities and the general public.

Red Dress Day is a direct response to President Biden's proclamation of May, 2021 that May 5th be recognized nationally as Missing and Murdered Indigenous Women (MMIW) Awareness Day. Subsequent social, legislative and cultural action/events at the National, State and Regional levels have expanded this issue to include girls and Two Spirits (indigenous LGBTQ).

The event combines Indigenous speakers & presentations including:

- A traditional Memorial Ceremony for MMIWGTS;
- ♦ A moderated Indigenous Women Speakers' Panel;
- ◆ Updates on California MMIWG2S legislation (AB1314 Feather Alert System) and other statewide initiatives by state legislators and tribal leaders (please note Governor Newsom's support of MMIWGTS initiatives.

◆ Indigenous storytellers, drummers, dancers and singers; and 5) A Red Dress art exhibit— on this day, and art display of red dresses will show support for the lives of MMIWGTS. (See the Smithsonian Museum of the American Indian article on their Red Dress Day Project.

Collaborative partnerships: This project is a collaboration between:

- ♦ SICG, Pajaro Valley Ohlone Indian Council, Sand City's Mayor's Office, Native California Research Institute, Standing Tall Women Circle.
- ♦ Grant and in-kind sponsors: The City of Seaside, Arts Council of Monterey County, and the California-American Water Company.
- Individual donors.

Red Dress Day is an event:

- Unique to the Tri-county area of Monterey, San Benito and Santa Cruz counties;
- ◆ That is open to Indigenous communities and to the general public to raise awareness of critical issues surrounding this national tragedy;
- That will increase intercultural dialogue, and create bonds of shared interest moving into the future;
- ◆ That will join a nationwide effort to increase awareness and transparency in support of MMIWGTS.

Outreach to the general public. The event will have the highest level of promotion and publicity including a targeted social media outreach to approximately 1-2,000 Facebook members. Online and conventional local newspaper articles, and local TV coverage.

2. Objectives and desired outcomes

SICG's goal is to ignite shared experiences and create unexpected connections that strengthen our Indigenous communities and non-indigenous allies. The central driving themes for this event: social justice; preservation, protection, and celebration of living cultural resources; and sustainable community building will allow us to accomplish this as follows:

- ♦ **Empowering** event participants to learn about Indigenous rights to culture, health, security and justice and to recognize that Indigenous women, girls and Two Spirits are also holders of these tribal rights that have been denied to MMIWGTS people.
- ♦ Creating an accessible Tri-county-wide event, that will raise awareness of critical issues surrounding this national tragedy; to increase intercultural dialogue, and to create bonds of shared interest.
- ♦ Joining a nationwide effort to increase awareness in support of MMIWGTS.
- ♦ Spark unexpected and welcome connections between art, history, ethnicity, and social justice by providing a rich cultural context to explore the primary issues of MMIWGTS.

Evaluation/Surveys:

- ◆ **Demographics:** We aim to engage 200-300 participants who will reflect the diversity of our Tri-Counties and will also measure attendance and audience demographics (age, race/ethnicity, zip code).
- ♦ Quality of event participant's experiences will be measured by a survey that will measure increase in awareness of MMIWGTS, feelings of increased civic/creative agency and established new connections-netwwork

3. Capacity

SICG has built an extensive network with academic institutions, schools, civic bodies, and community organizations to support indigenous activities that include:

- ♦ Cultural events for Native American/Indigenous communities in the Tricounty areas to gather and celebrate their respective cultures.
- ♦ Opportunities for Native American/Indigenous communities to collaborate and share important resources to benefit their families and communities.
- ◆ Raising awareness of critically important issues facing Native American/Indigenous communities such as the (MMIWGTS) crisis, and at the local level, endemic poverty, educational challenges etc.

Past events: SIGC Executive Committee members have organized/consulted or participated in Indigenous events and initiatives over the years. A few examples include but are not limited to:

- ♦ October 2018-2022 Annual Indigenous People's Day in Sand City, California.
- ♦ Gathering of the Elders, Watsonville, California, celebrating its 39th anniversary, this event is an intertribal California cultural exchange focusing on youth and family, emphasizing respecting our Elders, holders of Indigenous culture and values.
- ♦ December, 2022. SIGC Executive Members attended a MMIWGTS Feather Alert Roundtable hosted by the Native American Legislative Caucus and the Picayune Rancheria of the Chukchansi Indians and assisted in preparing the AB12314 Feather Alert rollout, ensuring effective policies and practices that meet Indian Country needs.
