ESSELEN-OHLONE PARK RIBBON-CUTTING CEREMONY

Sand City is proud to announce the completion of the all-new Esselen-Ohlone Park built by developer DBO 30 at the South of Tioga site. A safety tunnel has been constructed which allows for safe passage through the South of Tioga construction site via Morgans Way. The park is now open from dawn to dusk and accessible via Tioga Avenue.

A ribbon-cutting ceremony was held on May 23rd by Mayor Carbone to commemorate the grand opening of the park.

WEST END CELEBRATION - AUGUST 24 & 25, 2024

The West End Celebration, returns on August 24th and 25th, 2024, showcasing an exceptional lineup of musicians and artists across six vibrant blocks in Sand City. 

STORM WATER POLLUTION PSA




Can you find activities in this picture that contribute to water pollution?

Updates from the City Government







THE DAYLIGHTING SAVES LIVES BILL (AB 413, LEE)

In October of 2023, Governor Newsom signed Assembly Bill 413 into law. Known as "The Daylighting to Save Lives Bill," the law bans motor vehicles from parking, stopping, or standing within 20 feet of the vehicle approach side of any marked or unmarked crosswalk or within 15 feet of crosswalk where a curb extension is present.

This new law is intended to reduce traffic fatalities and injury collisions due to reduced visibility at intersections.

AB 413 allows for only warnings during the transition year of 2024, however, starting January 1, 2025, enforcement of the new parking restrictions should begin.

Parking is at at a premium in Sand City and the new restrictions present added challenges to the situation. Please be patient with the City as we comply with the new State mandate.





SAND CITY COASTAL TRAIL

Planning is underway for a trail that will connect Sand City's city-center to the coast! The trail will begin at Calabrese Park and will terminate at the West Bay Street viewing platform. The project will also include plans for parking improvements at the end of Tioga Avenue, educational signage, and a new viewing platform. Be on the lookout for upcoming community events where you can share your feedback on the design of the Coastal Trail. This project is made possible by grant funding from the State Coastal Conservancy.

SAND CITY MULTI-USE TRAIL PROJECT

City Staff held a kick-off meeting on May 9th, 2024, to initiate preliminary planning efforts for a new multi-use





trail connecting the existing Monterey Bay Coastal Recreation Trail along the TAMC railway corridor through Sand City. Since the kick-off meeting, City Staff has worked diligently with project consultants to complete aerial survey, focused plant studies, and conduct an initial review of future pedestrian crossings.

The City will hold engagement events with community members in order to obtain feedback for the final project design.

AMBAG GRANT AWARDS

Sand City was recently awarded \$1,960,000 through the Association of Monterey Bay Area Governments (AMBAG) Carbon Reduction program to support construction of the multi-use trail along the TAMC railway corridor.

CODE ENFORCEMENT

The City is charged with enforcing the City's municipal code. At the City Council's direction, code enforcement has focused its recent efforts on violations of conditional use permits in Sand City, such as



enforcement of storage and/or shipping container placement and operation of businesses without conditional use permits. If you have a container installed in a designated parking space, you may be required to move or relocate the container to an approved location.

Any business and/or resident with material, including waste, build materials, and/or supplies, that is not properly stored within the building or approved waste receptacle may be subject to fines and additional penalties.

SAND CITY HOUSING ELEMENT MEETS HCD COMPLIANCE

The City is pleased to announce that the City of Sand City's Housing Element received a compliance letter from HCD! EMC Planning Group assisted the City with crafting policies and programs that will directly identify and respond to the needs of the City's most vulnerable residents, and is collaborating with City staff and HCD to pursue Prohousing designation, which would provide funding for the implementation of the City's policies and programs, identified in the 6th Cycle Housing Element.

SAND CITY FAÇADE IMPROVEMENT PROGRAM

The City of Sand City is pleased to announce the availability of a limited amount of financial assistance to eligible commercial and mixed-use properties to improve the physical appearance of the exterior of the businesses.

The City Council has approved a Façade Improvement Program that assists owners and merchants to keep storefronts looking attractive and inviting.

The program benefits both building owners and tenants by reimbursing some, or all, of the cost of maintenance and repair and construction, on a case – by – case basis. The City will reimburse up to a maximum of \$5,000 upon completion of eligible improvements.

GENERAL ELECTION - NOVEMBER 5, 2024

The City of Sand City holds Municipal Elections in November of even-numbered years in the City of Sand City. The elective officers of the City consist of a City Council made up of four Councilmembers and an elected Mayor. The Mayor is elected every two years, and council members are elected to four-year terms.



Nomination papers for seats available is July 15 – August 9, 2024, by 5 PM. If an incumbent does not file by this deadline, the deadline for non-incumbents running for those seats will be extended to 5 PM on Wednesday, August 14, 2024.
